



- Underpins the livestock selling system, giving confidence to buyers, retailers and consumers





### LPA NVD ... what it means on-farm

LPA NVDs bring together all on-farm assurance, identification and traceability details.

- 1. The LPA NVD captures food safety information on every animal, every time it moves from property to property, to processors or saleyards.
- 2. NVDs provide evidence of livestock history and on-farm practices when transferring livestock through the value chain.







#### The eNVD system

The mobile-friendly, user-centric eNVD system is available to LPA accredited producers, feedlots and value chain stakeholders. It is:

- Always using the latest form versions
- Reducing time and duplication completing forms
- A central location to safely store consignments
- Always available (even in emergencies)
- Continuously improved based on your feedback and requirements








