#### National Livestock Identification System

From **1** January 2025 all sheep and farmed goats born on or after this date must be fitted with an approved NLIS electronic identification (eID) device before leaving their property of birth. Visual tags will no longer be accepted to identify sheep and farmed goats born after 1 January 2025. The eID devices must be approved by the National Livestock Identification System (NLIS) so that stock can be individually identified and traced through the NLIS database. An eID may have a **conditional or full approval status**. Devices with conditional approval are still under trial but can be sold commercially and used under the NLIS. Full approval may be granted to a device at the conclusion of field trials.
