- insight into consignments ahead of their arrival







### Where does the eNVD app fit within Integrity Systems Company's (ISC's) digital strategy?

ISC is working to support the industry's goal of increasing uptake in digital consignments through the electronic National Vendor Declaration platform – or **eNVD**.

The **eNVD** platform is a suite of technologies which support end-to-end digital transfer of livestock consignments including LPA NVDs, MSA Vendor declarations, national health declarations and NFAs forms.

- Allows transfer of a consignment from a producer's device to a transporter or receiver's device without mobile service.

- Tracks consignment progress ahead of arrival.
- Reduces costs of storing and retrieving consignment information.
- Improves data flow.
- Ensures the latest versions of NVD are used.

- Engaging a trained consultant team to partner with supply chain stakeholders in developing bespoke adoption plans to assist in uptake of digital consignments.
