

## Alternate Feedstuff Declaration (Cotton Trash)

This declaration **must** be completed and signed by the owner / manager of the Livestock Production Assurance (LPA) accredited property receiving each consignment of cotton trash before it is released from the gin or cotton trash storage site.

## Declaration

I, ..... (print full name), declare that I am the owner / manager of the Property and PIC identified above, and I agree to abide by the following requirements as a condition of receiving cotton trash from the cotton gin named above. Specifically, I warrant that:

- 1. The Supply Details given above are correct and I authorise and direct the Supplying Gin to provide this form signed by me to the Livestock Production Assurance (LPA) administrator.
- 2. I will provide a copy of this declaration to the LPA administrator within seven (7) days of it being signed.
- 3. I have been provided by the Supplying Gin with a completed Commodity Vendor Declaration for the supply of this cotton trash.
- 4. I have been provided with, read and understood the fact sheet attached to this declaration which lists the residue and commercial risks associated with having cotton trash delivered to the Property for feeding to livestock or for use as mulch.
- 5. In accepting delivery of cotton trash to the Property, I agree that the Property Identification Code (PIC) for that Property will have an "Accessed Cotton Trash" status applied which will be disclosed on the NLIS database.
- 6. Livestock that have had, or may have had, access to cotton trash either as stock feed or as mulch must be grazed on clean feed for a period of at least 60 days prior to dispatch for slaughter or export (**Clean Feed Period**).
- 7. Livestock resident on the Property will have an "Accessed Cotton Trash" device-based status applied to their individual NLIS devices and that status will be disclosed on the NLIS database; this status will remain active until the livestock have been verified as having completed the Clean Feed Period.
- 8. The commencement of the Clean Feed Period will be verified by an Approved Auditor who will sign a LPA Clean Feed Verification Form to the producer verifiying provided by the LPA administrator to verify the commencement date of the Clean Feed Period (**Verification**). This Verification will be arranged by me at my own cost.
- 9. If livestock are moved to another PIC prior to the completion of their Clean Feed Period, this status will remain active until this Clean Feed Period has been completed.
- 10. Movement of any livestock from the Property within their Clean Feed Period will be notified by me to the NLIS database within one (1) day of that movement having taken place.
- 11. If moving livestock to another PIC prior to the completion of the Clean Feed Period, I will disclose on the LPA National Vendor Declaration (NVD) that these livestock have, or may have, accessed cotton trash.
- 12. I will provide to the LPA administrator this Verification within two (2) days of it having been signed, together with a list of NLIS devices attached to the livestock that are verified as being grazed on clean feed.
- 13. I have a management plan in place to ensure the production system allows access to clean feed for 60 days, and I acknowledge that the Property will be subject to the LPA random audit process to ensure such a management plan is in place.
