



NLIS Approved Cattle Devices

Under the NLIS, all cattle in Australia are required to be identified with an individual electronic identification device also known as an RFID or eID. The use of eID allows the recording of stock movements on the NLIS database so that animals can be traced individually.

An eID must obtain NLIS approval from Integrity Systems Company before it can be used. Approval requirements are contained in the NLIS Animal Identification Technology (NLIS AIT) Requirements, which detail minimum mandatory specifications for devices. Devices may have a **conditional or full approval status**. Devices with conditional approval are still under trial but can be sold commercially and used under the NLIS. Full approval may be granted to a device at the conclusion of field trials.
