#### The eNVD system


The eNVD is system for completing all consignment details digitally including livestock assurance and health declarations. eNVD is available to LPA accredited producers, feedlots and value chain stakeholders.

- eNVDs are easy to read and don't get lost as stored online
- Reduces time and duplication completing forms
- Increased completeness of information, as incomplete eNVDs cannot be submitted
- Simplifies LPA audits all in one place and easy for the auditor to find
- eNVDs are accepted as a legal and compliant document
- \$30 discount on LPA Accreditation if using eNVDs

### The eNVD mobile app is here!

- A complete digital mobile solution
- Works offline
- Complete and transfer consignment forms offline using QR codes
- Templates save time and prevents errors
- Reduces duplication
- Editable within 48 hours of movement
- PIC register search capability built into the app

### Work continues! Updates in the pipeline

Continuing to update app functionality and features to deal with the complexity of red meat supply chains.

- Notifications to alert receivers to consignments that have been created
- Comments for flagging head count discrepancies or leaving notes on where livestock have been left.
- Attachments to capture other documents that may need to accompany the stock.
- Allow saleyard buyers info to be added to consignment.
- More consistency between website and mobile app interfaces.

### How do I get started?

- 1. Ensure your PIC is accredited with LPA
- 2. Create a myMLA account and link LPA account
- Speak with your transporter and receiver to ensure they're ready to receive paperless consignments and check you have the correct destination PIC
- 4. If they're not, work out a plan to send an email copy or printouts of the eNVDs
- 5. Download the app and create a consignment!







#### eNVD app take-home messages

- Works offline use QR codes to transfer consignment data from producer to transporter when no service
- Editable within 48 hours of movement
- The PIC is key for eNVD addressability
  - PIC register search capability built into the app
  - eNVDs can be addressed to both the destination AND an agent PIC
- Remember to check your receiver, including your agent and saleyard, is ready to receive digital consignments
- For those receivers who still require paper, eNVDs can be printed or emailed and sent with the stock
